

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to shorelinesailboats.com and Shoreline Sailboats and governs data collection and usage. Shoreline Sailboats provides recreational sailboats, both new and used throughout the region on New York State and contiguous U.S. site. By using the Shoreline Sailboats website, you consent to the data practices described in this statement.

Privacy Compliance Certification

Shoreline Sailboats has SSL certificate certification.

Collection of your Personal Information

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services available on the Site. These may include: (a) registering for an account on our Site; (b) entering a sweepstakes or contest sponsored by us or one of our partners; (c) signing up for special offers from selected third parties; (d) sending us an email message; (e) submitting your credit card or other payment information when ordering and purchasing products and services on our Site. To wit, we will use your information for, but not limited to, communicating with you in relation to services and/or products you have requested from us. We also may gather additional personal or non-personal information in the future.

Sharing Information with Third Parties

Shoreline Sailboats does not sell, rent or lease its customer lists to third parties.

Automatically Collected Information

Information about your computer hardware and software may be automatically collected by Shoreline Sailboats . This information can include: your IP address, browser type, domain names, access times and referring website addresses. This information is used for the operation of the service, to maintain quality of the service, and to provide general statistics regarding use of the Shoreline Sailboats website.

Use of Cookies
